#### Terms & Conditions

##### Who is Eligible to Participate?

Any person who is directly responsible for the decision making and order placement and/or approval of **Smucker's® Snack'n Waffles®** Brand Waffles and/or **Smucker's® Uncrustables®** Sandwiches and/or **JIF® Peanut Butter** for his/her school district. Only one individual per school district can be designated to submit qualifying purchases and accrue associated points. Both new<sup>1</sup> and existing customers are eligible to accrue points.

##### Exclusions

- If you work for the U.S. Government you are not eligible to participate.
- If your employer has a policy prohibiting employees from participating in reward promotions, you should not participate.
- All participants will have the option to redeem points and receive the associated award personally or assign any award to his/her school district.

##### Qualifying Product Purchases

##### Establishing Your Smucker's Rewards In Hand Program Account, Reporting Your Qualifying Product Purchases, and Redeeming Your Points for Gift Rewards

- Go to the program site [www.RewardsInHand.com](http://www.RewardsInHand.com) and click on the "Register" button on the left side of the page. You will be taken to the sign in page.
- Fill out the registration form and provide the requested information to create a new account on the program site [www.RewardsInHand.com](http://www.RewardsInHand.com).
- Once you have created an account with a login and password, sign in to verify proof of purchase of eligible Smucker Foodservice products of **Smucker's Snack'n Waffles** Brand Waffles and/or **Smucker's Uncrustables** Sandwiches and/or **JIF Peanut Butter** in 4 lb. containers or 1.1 oz. cups.
- Accumulate points for these purchases by submitting/uploading the requested proof of purchase documentation for reporting and verification of purchases.

- A scanned invoice, distributor velocity report or internal school report are all acceptable proofs of purchase.
- Registered account users will receive a report of their accumulated points sent via email on a monthly basis. Users can also log in to their accounts to check the accumulated points.
- Users can sign in to their accounts on [www.RewardsInHand.com](http://www.RewardsInHand.com) to redeem points for rewards throughout the program period.
- You can register at any time with the final deadline of March 11, 2016, for enrollment.

**NOTE:** You cannot submit and accrue points until you have completed the registration and account setup through the program site [www.RewardsInHand.com](http://www.RewardsInHand.com).

##### (1) Final Purchase Date: March 11, 2016

- The final purchase date would be the last date customers are allowed to purchase Smucker Foodservice products to qualify for points and rewards.

##### (2) Points Redemption Deadline: March 25, 2016

- The points redemption deadline is the final date customers can submit invoices to redeem points for validation.

##### (3) Rewards Redemption Deadline: April 15, 2016

- The Rewards Redemption Deadline is the final date to redeem rewards from the program.
