What are your business hours?

Our business hours are: Monday thru Friday 8 am to 8 pm CST.

What guarantee does your company offer?

Do you charge sales tax?

Sales tax is charged only on orders shipped to an Illinois address.

Will my shirts look exactly like what I designed on-line?

The on-line design module provides a general proof confirming your garment type, color, and artwork (including imprint colors, size and position). This proof directly guides our professional staff to produce your order to your specifications.

What forms of payment do you accept?

You may make payment using Visa, Mastercard, and American Express. Orders are processed securely using Secure Socket Layer Technology. Purchase Orders (P.O.'s) are accepted but are reserved for qualified organizations such as schools, government agencies and large corporations. Purchase Orders must be verified and therefore can only be placed by phone.

Do you allow changes to an order?
